

Privacy Policy

1. Your Consent

By using the Amiri web site you indicate your consent to the collection and use of personal data about you as described below in accordance with this policy statement. Should we choose to change these terms for any reason, the changes will be posted here so that you are always kept informed about the collection and use of your personal information, and when we disclose it.

2. How do we collect personal information about you?

You supply information to us by completing our 'Contact us' form or by writing, faxing, emailing or telephoning us.

3. How is your personal information used?

We may use personal information collected about you to respond to an enquiry made by you.

If you have chosen to join our mailing list we may use your information to:

4. Who is your information used by?

6. How do we protect your information?
